

8 Fleet Street - Fairholm



Nos. 6 & 8 Fleet Street

◀ Chronology of Ownership & Occupancy ▶

Prior to 1883 nos.6 & 8 Fleet Street were under single ownership. As a result occupancy cannot be pinpointed to individual houses. Details of the combined properties are included with no.6 until 1883 after which date they are separated.

1883 Sold to Peter Wyllie, grocer, Gatehouse.

This sale probably refers to no.8 only. From 1883 nos. 6 & 8 Fleet Street are under separate ownership.

1884-85 Anwoth Valuation Roll : Peter Wyllie, grocer, High Street, Gatehouse, owned a house and garden in Fleet Street that was occupied by William Campbell, coachman.

These 2 families were allocated to no.8 Fleet Street because they came between the Caig / Wilson families at no.6 and the McTaggart / Milroy / Davidson families at no.10 Fleet Street. The families must have moved quickly as the house was empty a year later (valuation roll)

1912-13 Anwoth Valuation Roll : A house in Fleet Street managed by the Trustees of the late Peter Wyllie, grocer, High Street, was empty.

1914 Belonging to trustees of late Peter Wyllie, formerly grocer, Gatehouse, Rev James Clark, UP church, Gatehouse and James McMichael.

1921 Sold by trustees of Peter McMichael to John Reid.

1921-22 Anwoth Valuation Roll : John Reid, insurance agent, owned 2 houses in Fleet Street that were occupied by (1) James Milroy, rabbit catcher and (2) David Wilson, labourer.

The combined Annual Rent or Value for the 2 houses was £9 1s 1d and the same value for the property owned by John Reid in 1930-1 was £9 1s. It must therefore be assumed that in 1921-22 the 2 houses were 6 & 8 Fleet Street, but that from 1930-31 they were combined as no.8 Fleet Street.

1930-31 Anwoth Valuation Roll : John Reid, insurance agent, owned and occupied a house in Fleet Street.

1940-41 Anwoth Valuation Roll : John Reid, retired, owned and occupied the house at 8 Fleet Street.

1950-51 Anwoth Valuation Roll : Helen T R Reid, owned and occupied Fairholm, no.8 Fleet Street.

1960-61 Anwoth Valuation Roll : Helen T R Reid, owned and occupied Fairholm, no.8 Fleet Street.

1962 Disposed by Helen Cullen or Reid to Hamilton McCreadie, farmer, Kirkbride
