Dunmore Boddan, servant at Cullendoch voluntarily 'acknowledged herself with child in uncleanliness'. Named Peter Lyons, servant Barwhinnock, Twynholm as father of her child.

James [Hird] Newton Stewart, parish of Penningham charged with adultery with late Jean [Abell] of this parish.

Jannet Currance, in Disdow, voluntarily 'acknowledged herself with child in uncleanliness'. Named Alexander Purdie, in Gatehouse, as father of her child.

Alexander Purdie in Gatehouse declared that he is not the father of Janet Currance's child and has had no carnal knowledge with her within the last four years.

1821 22nd July at Girthon Kirk Rev Robert Jeffrey & elders

Janet Currance, in Disdow adhered to her accusation that Alexander Purdie is the father of her child. It was begot on the 4th night of last Gatehouse Market (8th December). Alexander Purdie admitted having conveyed Janet Currance on that night from Mr Joseph McNichol's to the Tollbar but no further. Repeated his declaration of 24th June.

Euphemia Donaldson, Drumruck voluntarily confessed she is with child in fornication. Declared Henry Campbell, dyker of Newton Stewart is the father of her child.

Letter from David Hutchison, in Rhonehouse, Kelton acknowledging himself as the father of Euphemia Donaldson's child and engaging to contribute to the infant. The Session decided to report the case to the Session of Kelton and as it was a case of adultery to lay it before the Presbytery.

Susan Currance, in Disdow who confessed that she had a child in fornication in March 23. She had named father as Patrick Kerr, which was false. She was severely reprehended for the ? of her guilty conduct. She declared Alexander Wilson, weaver in Gatehouse as the father of her child.

Session had informed the Modr. of Parish of Kelton of the case of David Hutchison union with Euphemia Donaldson.

James Rain, Townhead elected to represent the Girthon Kirk Session at Presbytery of Kirkcudbright and Synod of Galloway for current half year.

Janet Walker in Gatehouse confessed that she had had a child in uncleanliness. Declared James Woods (fishmonger) at present in Barwhinnock is the father. The Girthon Session will notify Twynholm Session to ask Woods to appear before them on the charge of being father of the child.

Jean McWhan in Gatehouse confessed that she had had a child in fornication. Declared that John Roberts, a miner, late in Gatehouse, now gone to Carnwath is the father of her child.

Euphemia Donaldson, was rebuked for the sin of adultery with adultery David Hutchison in Rhonehouse.

Mary Dixon in Skyreburn, formerly servant in Rainton confessed herself with child in fornication. Declared Robert McKie, late servant at [Kirk] of Girthon, now gone to Canada, as father of her child.

John Ramsay, labourer, in Gatehouse rebuked for ante nuptial fornication with his wife Isabel [Sirrat].

Samuel Carnachan in Little Barlay and Agnes Hathorn in High Creoch rebuked for the sin of fornication.

Alex. Purdie, flesher, in Gatehouse who was rebuked for fornication is restored to the privileges of the church.

No objections raised to the above elders' nominations.

Janet Currance in Disdow, declared that James Rain, in Townhead, a married man and an elder of this church is the father of her child when some years ago she declared Alexander Purdie in Gatehouse, the father. She now rebuked her former statement.

Mr Rain, being present and having heard the above declaration of Janet Currance denied the same as utterly false. Both parties ordered to appear before them again next Thursday.

Janet Currance of Disdow and James Rain again appeared before the Session. Mr Rain again denied the charge. Scandals such as this case have to be referred to Presbytery of Kirkcudbright.

John McConchie, weaver, in Gatehouse rebuked for ante nuptial fornication with his wife Ann Milligan.

1825 30th October at Girthon Kirk Rev Robert Jeffrey & elders

John Denniston in Quarterland elected to represent the Girthon Kirk Session at Presbytery of Kirkcudbright and Synod of Galloway for current half year.

1825 11th December at Girthon Kirk Rev Robert Jeffrey & elders

Janet Carson in Gatehouse confessed she is with child in uncleanliness and declared Charles McGaw, mason, formerly of Gatehouse and at present in Edinburgh as the father of her child.

23

Charles McGaw has sent a letter to his friends in Gatehouse acknowledging that he is the father of Janet Carson's child and it was therefore agreed that the child should be baptized.

Elizabeth Brown in Gatehouse confessed that she is with child in fornication. She declared that Hugh Walker, weaver in Gatehouse is the father of her child.

Margaret Henderson, daughter of Musgrave Henderson, weaver in Gatehouse confessed that she is with child in uncleanliness. Declared Matthew Callahan, weaver in Millburn, Kirkcudbright is the father of her child.

Robert Hathorn rebuked for ante nuptial fornication with his wife Helen McGill.

Letter sent by Mary Carnie, mother of James Carnie who was proclaimed in church this day for marriage with Jean Nixon. Mary Carnie states that Jean Nixon is a married woman and lived for a considerable time in Gatehouse with her husband James Divine who is still alive. Session decided to defer marriage and ordered the mother to bring forth proof before Thursday next.

1826 10th September at Girthon Kirk Rev Robert Jeffrey & elders

Elizabeth Credie from Creetown acknowledged she is with child in uncleanliness. Declared William McNish, writer in Gatehouse as father of her child.

1826 17th August at Girthon Kirk

Rev Robert Jeffrey & elders

James Carnie and Jean Nixon could not disprove that a previous marriage between Jean Nixon and James Devine had taken place so the marriage between James Carnie and Jean Nixon could not take place.

William McNish, writer in Gatehouse denies ever having had any carnal connections with the said Elizabeth Credie.

28

1826 16th November at Girthon Kirk Rev Robert Jeffrey & elders

Elizabeth Credie was asked for proof of her accusation that William McNish was the father of her child. Said that Rosanna McWilliam witnessed her and William McNish coming out of his house and walking towards the bridge. Asked if they went further, she said 'a little on the Corse Road where she was guilty with McNish for the first time'. She also admitted to having been in his room on the Saturday before New Years Day.

She admitted sending a letter to McNish about the time of the last Keltonhill Fair. She also admitted another involvement at the Woods.....but did not know his name. She was asked if it was her husband and she said it might be. Rosanna McWilliam denied seeing McNish and Elizabeth Credie together either in public or private. Session decided that there was no evidence of guilt by Mr McNish.
